WATER AND SEWER AUTHORITY OF CABARRUS COUNTY MAY 19, 2022 5:00 P.M.

The Board of Directors (the "Board") of the Water and Sewer Authority of Cabarrus County ("WSACC") met in regular session on Thursday, May 19, 2022 at the Administrative Offices. The meeting was also set up for virtual attendance administered by Zoom and streamed on YouTube.

At 5:00 P.M., Chairman Legg called the meeting to order.

UNFINISHED BUSINESS

Request for Approval of the Minutes of April 21, 2022

Mr. Marshall made a motion to approve the April 21, 2022 minutes. Mr. Shue seconded the motion and the Board approved by unanimous vote.

NEW BUSINESS

Request for Approval of the Full Guaranteed Maximum Price (GMP) #3 for the Rocky River Regional Wastewater Treatment Plant (RRRWWTP) Expansion

At WSACC's April 21, 2022 Board meeting, the Board approved the interim GMP #3 for an amount of \$13,538,261 to enable Crowder Construction to purchase construction supplies that were needed to complete Phase 3 of the RRRWWTP expansion.

Mr. VonCannon said WSACC has thoroughly reviewed the final GMP #3 and discussed the cost sharing for the RRRWWTP Phase 3 expansion with Charlotte Water.

Mr. VonCannon then requested approval of the remaining GMP #3 in the amount of \$64,228,086 which would bring the total GMP #3 for Phase 3 of the RRRWWTP expansion to \$77,766,347.

Mr. Hinnant made a motion to approve the full GMP #3 for the RRRWWTP expansion. Mr. Shue seconded the motion and the Board approved by unanimous vote.

Request for Approval of an Increase in the Capital Project Ordinance (CPO) for the RRRWWTP Expansion CPO Budget by \$65,787,120 to a Total of \$105,153,673

Mr. Wilson presented the CPO for the RRRWWTP expansion budget. He said the CPO includes the final negotiated contribution from Charlotte Water for \$38,985,223, and the CPO recognizes the remainder of the GMP #3 required to complete the construction of the RRRWWTP expansion to 30 MGD.

Mr. Wilson said System Development Fee (SDF) revenues had been reduced from \$8,412,000 to \$378,450, freeing up \$8,033,550 SDF's and he would like to move that to the Lower Coddle Creek Parallel Interceptor CPO.

Mr. Wilson then requested the Board's approval of the amendment to the CPO for the RRRWWTP expansion.

Mr. Ritchie made a motion to approve the increase in the CPO for the RRRWWTP expansion CPO budget by \$65,787,120 to a total of \$105,153,673. Ms. Hubbard seconded the motion and the Board approved by unanimous vote.

The CPO was approved as follows:

Request for Approval of the Capital Project Ordinance for the Lower Coddle Creek Parallel Interceptor Budget, Increasing System Development Fees (SDF) and Removing Bond Proceeds

Mr. Wilson said the purpose of the Lower Coddle Creek Parallel Interceptor CPO amendment was to recognize transferring \$8,033,550 of SDFs over to the RRRWWTP expansion project. He explained that after issuing bonds for the RRRWWTP expansion and determining the final participation amount from Charlotte Water, it was determined that \$8,033,550 in SDFs could be moved to the Lower Coddle Creek Parallel Interceptor project and not incur any additional debt by issuing bonds.

The CPO was approved as follows:

REPORTS

RRRWWTP Expansion Update

Mr. VonCannon provided the following update from Crowder Construction on the RRRWWTP expansion project.

- Crowder Construction completed the installation of approximately 3000 liner feet of electrical duct bank.
- Crowder Construction completed the drilling for the new aeration basin.
- The RRRWWTP expansion project received authorization to construct from NCDEQ.

Mr. VonCannon said throughout the next month, Crowder Construction expects to continue with the duct bank rebar tying and the utility locates for duct bank installations. Crowder Construction will begin the work on pads for pad mounted electrical equipment. Excavation for the new aeration basin is expected to begin in June 2022.

Capacity Historical Trends and Current Information

Mr. Wilson provided data with information on WSACC's historical capacity trends for wastewater flows and for allocated but not yet connected flows. He also provided data showing the historic average rainfall compared to the actual rainfall in Cabarrus County.

A copy of the presentation is filed in the Secretary to the Board's office.
