The Board of Directors (the "Board") of the Water and Sewer Authority of Cabarrus County ("WSACC") met in regular session on Thursday, August 17, 2023 at the Administrative Offices. The meeting was also set up for virtual attendance administered by Zoom and streamed on YouTube.

At 4:00 P.M., Chairman Legg called the meeting to order.

UNFINISHED BUSINESS

Request for Approval of the Minutes of July 20, 2023

Mr. Ritchie made a motion to approve the minutes of July 20, 2023. Mr. Hinnant seconded the motion and the Board approved by unanimous vote.

CONSENT AGENDA

Mr. Hinnant made a motion to approve the items of the Consent Agenda as presented. Mr. Shue seconded the motion and the Board approved by unanimous vote.

The Consent Agenda items were approved as follows:

Request for Approval of the Reimbursement Resolution for the RRRWWTP Expansion Project Phase 4

The IRS requires that the Reimbursement Resolution be adopted to allow WSACC to reimburse itself with tax exempt bond proceeds for expenditures made 60 days prior to the date of the adoption and ending on the date WSACC issues the bonds.

Due to WSACC's efforts to accelerate the RRRWWTP Expansion Phase 4 project as quickly as possible, it is necessary to have the resolution in place so WSACC can reimburse itself for any costs incurred before issuing debt.

RESOLUTION REGARDING THE INTENT OF THE WATER AND SEWER AUTHORITY OF CABARRUS COUNTY TO REIMBURSE ITSELF FOR CAPITAL EXPENDITURES INCURRED IN CONNECTION WITH CAPITAL PROJECTS FROM THE PROCEEDS OF TAX EXEMPT OBLIGATIONS

WHEREAS, the Board of Directors (the "Board") of The Water and Sewer Authority of Cabarrus County ("WSACC") has determined that it is in the best interests of WSACC to pay the costs of the expansion of the Rocky River Regional Wastewater Treatment Plant known as "Phase 4"(the "Project");

WHEREAS, WSACC reasonably expects to receive the proceeds of the sale of one or more series of tax-exempt obligations (the "Obligations") to finance the Project;

WHEREAS, WSACC desires to proceed with the Project and will incur additional capital expenditures (the "Capital Expenditures") in connection therewith before the issuance of the Obligations; and

WHEREAS, WSACC will advance money from funds currently on hand to pay for the Capital Expenditures and WSACC intends, and reasonably expects, to reimburse itself for the Capital Expenditures from a portion of the proceeds of the sale of the Obligations;

NOW, THEREFORE, BE IT RESOLVED by the Board of Directors of The Water and Sewer Authority of Cabarrus County as follows:

Section 1. *Official Declaration of Intent.* WSACC presently intends, and reasonably expects, to reimburse itself for the Capital Expenditures incurred and paid by WSACC on or after the date occurring 60 days prior to the date of adoption of this Resolution from a portion of the proceeds of the Obligations. WSACC reasonably expects to issue the Obligations to finance the costs of the Project and the maximum principal amount that WSACC expects to reimburse itself from the proceeds of the Obligations for the costs of the Project is \$93,300,000.

Section 2. *Compliance with Regulations*. This Resolution is a declaration of official intent of WSACC under Section 1.150-2 of the Treasury Regulations promulgated under Section 103 of the Internal Revenue Code of 1986, as amended, to evidence WSACC's intent to reimburse itself for the Capital Expenditures from proceeds of the Obligations.

Section 3. *Itemization of Capital Expenditures*. The Executive Director of WSACC or his designee, with advice from bond counsel, is hereby authorized, directed and designated to act on behalf of WSACC in determining and itemizing all of the Capital Expenditures incurred and paid by WSACC in connection with the Project during the period commencing on the date occurring 60 days prior to the date of adoption of this Resolution and ending on the date of issuance of the Obligations.

Section 4. Effective Date. This Resolution is effective immediately on the date of its adoption.

Request for Approval of the Updates to the Electronic Communications and Devices Policy

The following procedures in WSACC's Electronic Communications and Devices Policy have been modified to read as follows:

E. Use of Portable Recorders

WSACC employees are prohibited from using department-issued portable recorders or personally owned portable recorders without the consent of all parties' knowledge of recording. This includes but is not limited to mobile phones, and cameras. Employees who have a legitimate reason to record information without the consent or knowledge of all parties must have written permission from the Executive Director. A violation of this policy may result in disciplinary action, including termination.

WSACC recommends that the Board approve the Electronic Communications and Devices Policy to be effective on August 17, 2023.

Request for Approval of Three (3) Resolutions Authorizing Condemnation to Acquire Property for the Lower Coddle Creek Parallel Interceptor Project

WSACC has been unable to acquire property needed for the Lower Coddle Creek Parallel Interceptor Project ("Project") from three (3) property owners.

It is requested that the Board approve the resolutions entitled "<u>Resolution Authorizing Condemnation to Acquire Property"</u> for the properties associated with the Lower Coddle Creek Parallel Interceptor Project.

RESOLUTION AUTHORIZING CONDEMNATION TO ACQUIRE PROPERTY

WHEREAS, the Board of Directors of the Water and Sewer Authority of Cabarrus County ("WSACC"), hereby determines that it is necessary and in the public interest to acquire certain property owned by those persons, firms or corporations identified in Schedule 1 for the following public purpose:

To protect the public health, to provide the public with an adequate and sound water and sewer facilities, and to improve such system to meet the need for expanded or upgraded services, WSACC is condemning the herein described interest for public utility purposes, specifically, for the purpose of constructing and extending the Lower Coddle Creek Parallel Interceptor Project in accordance with the plat(s) thereof attached hereto as Schedule 2.

WHEREAS, to date, representatives of WSACC have been unable to acquire the needed interest in the described property by negotiated conveyance.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF DIRECTORS OF WSACC, THAT:

- WSACC shall acquire by condemnation, for the purposes stated above, the property and interest therein described in <u>Schedule 1</u> attached hereto and incorporated herein by reference.
- Attorneys representing WSACC are directed to institute the necessary proceedings under Chapter 40A of the North Carolina General Statutes to acquire the property herein described.

NEW BUSINESS

Request for Approval of the Guaranteed Maximum Price #1 for the RRRWWTP Expansion Phase 4

Mr. VonCannon presented the first Guaranteed Maximum Price (GMP) for the RRRWWTP Phase 4 expansion project. Crowder Construction worked with WSACC staff to complete GMP #1. A copy of GMP #1 was included in the agenda packet.

Mr. VonCannon said the purpose of GMP #1 was to proceed with the early procurement of several pieces of major equipment that have very long lead times. He said the total amount for GMP #1 was \$21,039,351 which includes items such as the additional blowers needed for Phase 4 along with the ductile iron pipe, valves and actuators, electrical gear stainless steel pipe for the blower building and the instrument & controls needed for Phase 4.

Mr. Shue made a motion to approve GMP #1 for the RRRWWTP Expansion Phase 4. Mr. Ritchie seconded the motion and the Board approved by unanimous vote.

Request for Approval of the Budget Amendment for RRRWWTP Expansion Phase 4 GMP #1

Mr. Wilson requested an amendment to the Capital Project Fund in the amount of \$21,039,351 for GMP #1 for the RRRWWTP Phase 4 expansion project. The budget amendment would bring the total Capital Project Fund budget to \$28,851,601.

Ms. Hubbard made a motion to approve the budget amendment for RRRWWTP Expansion Phase 4 Guaranteed Maximum Price #1. Mr. Sells seconded the motion and the Board approved by unanimous vote.

The Budget Amendment was approved as follows:

AN ORDINANCE TO AMEND A CAPITAL PROJECT FUND ORDINANCE

WHEREAS, the Board of Directors of the Water and Sewer Authority of Cabarrus County, North Carolina (WSACC) did on the 16th day of June 2022, adopt the RRRWWTP Expansion Design and Construction to 34 MGC Project Ordinance; and

WHEREAS, the Board of Directors of WSACC has determined that it is appropriate to amend the Capital Project Ordinance for the reasons stated below; and

NOW, THEREFORE, BE IT ORDAINED by the Board of Directors of the Water and Sewer Authority of Cabarrus County, that in accordance with the authority contained in G.S. 159-13.2, the ordinance is amended as shown and that the total amounts are herewith appropriated for the purposes shown.
